## 1.0 INTRODUCTION

### General Profile

**Ircon International Limited (IRCON)**, a government company, was incorporated on 28th April, 1976, in Delhi under the name Indian Railway Construction Company Limited mainly for the purpose of construction of Railway Projects in India and abroad on commercially prudent lines with the help of expertise from Railways. The name of the Company was changed to "Ircon International Limited" w.e.f. 17th October 1995 in tune with the international image and scope of operations of the Company.

The Company was originally registered as a private limited company with an authorized share capital of Rs.10 crores and equity paid-up share capital of Rs.10.02 lakhs, wholly contributed by the Government through Ministry of Railways. This paid-up share equity capital was increased by the Government from Rs. 10.02 lakhs to Rs.4.949 crores in 6 tranches from the year 1976 to 1985. 0.27% of paid-up share capital was disinvested by the Government of India in 1991-92 in favour of UTI (now with IRFC) and Bank of India Mutual Fund (now with Bank of India). As a result the Company was converted into a public limited company and its shares were got listed on Delhi and Mumbai stock exchanges in 1992. However, Ircon continues to be a Central Government Company under section 617 of the Companies Act 1956, with 99.715% of the share capital owned by the Government through the Ministry of Railways.

The initial authorized share capital of Ircon was Rs.10 crores and presently it stands at 400 crores and the subscribed and paid-up share capital is Rs.94.051 crores.

Ircon is – (a) A Schedule 'A' Company w.e.f. 15th May 2006; (b) A Mini Ratna Category -I since 1998; (c) A MoU signing Company since 1991- 92; (d) An ISO certified Company for Quality Management System for the organization since 1996, Environment Management System from 2011 and Occupational Health and Safety Management System (certified during 2012-13); and (e) A profit



making company since 1977-78, a regular dividend payer from 1980-81, and a regular foreign exchange earner from 1981-82 without any lapse in any year.

Ircon is no more a listed company w.e.f. 15.03.2012. The equity shares of Ircon stand delisted from Bombay Stock Exchange w.e.f. 03.11.2011 and from Delhi Stock Exchange w.e.f. 15.03.2012. However the government of India announced listing of shares of company in the budget for 2017-18 and accordingly the process of listing of shares is presently going on.

### Operational Profile

The Company started its operations in 1977-78 and entered international market in a big way with a major breakthrough in Iraq followed by Algeria. Completion of project in time conforming to international standards earned for Ircon its reputation as one of the leading construction companies of India. Commencing its operations exclusively in the railway sector, the Company diversified its activities in 1985 to other constructions too. The scope was further enhanced in 1993 to include projects on BOT, BOOT, BLT etc., business relating to leasing, real estate, etc.

The core competences in order of priority are – Railways, Highways & EHT Sub-station Engineering and Construction. The Company has executed projects operated in the areas of Railways construction including ballast less track, electrification, tunneling, signal & telecommunication as well as leasing of locos, construction of roads, highways, commercial, industrial & residential buildings and complexes, airport runway and hangars, metro and mass rapid transit system, etc.

Presently, it is executing projects abroad in Myanmar, Nepal, Bangladesh, Algeria and South Africa. In India, it is executing several prestigious projects which include Construction of Corridor-III of East-West Corridor between Gevra Road to Pendra Road in State of Chhattisgarh and feasibility study in the State of Chhattisgarh; Doubling projects at RDUM-TAL-RJO (Rampur Dumra Tal Rajendrapul) project, Kiul Gaya, Hajipur- Bachwara, Katni-Singrauli project; Execution of Rail Coal Connectivity Project(s) in the state of Jharkhand, Odisha and Chhattisgarh. Execution of civil and railway allied works in connection with construction of private Railway siding for proposed Integrated Steel Plant at Nagarnar, Chhattisgarh; Akhaura – Agartala Rail Link project; Design and construction of Civil Building & Track Works of Dedicated



Freight Corridor Project Vaitarana-Sachin Section; Additional work of Design, Drawing and Construction of External Development works & External Services at National Institute of Technology (NIT), Mizoram; Six-Laning of Davanagere-Haveri section of NH-48 in the State of Karnataka; and Additional works for Construction of Road Over Bridges (RoB's) in the State of Bihar (New RoB's-12) for East Central Railway.

Other projects under execution in India include BG New Railway line from Dharam to Qazigund in J&K; New Rail Coach Factory at Rae Bareli, U.P.; Construction of Corridor-I of East Corridor in the State of Chhattisgarh; Sivok-Rangpo New Rail Line Project; Road Over Bridges (RoBs) in the State of Bihar and Rajasthan; Widening and Strengthening of Bikaner Phalodi section of NH-15 in the State of Rajasthan; Four laning of Shivpuri-Guna Section of NH-3 in the State of Madhya Pradesh; Construction / upgradation of rural roads under Pradhan Mantri Gram Sadak Yojana (PMGSY) in Jharkhand and Bihar; RAPDRP Project in Jammu province in J&K; Rail link between Jayanagar (India) – Bijalpura (Nepal) and between Jogbani (Bihar) India to Biratnagar (Nepal), Electric Loco sheds at Bondamunda, Daund, and Mughalsarai; Coaching Terminal at Shalimar; Development of Circulating area at Santragachi and essential passenger amenities and road connectivity to Kona expressway; Metro works for Delhi Metro etc.

Major Projects secured after the close of the year 2016-17 includes Augmentation of Diesel Loco shed in Visakhapatnam; Katni Grade Separator for West Central Railway; Re-development of Safdarjung Railway Station; Railway electrification work for Katni-Singrauli; and Mathura-Kasganj-Kalyanpur Railway Electrification Project with Signalling.

During the year, the Company has completed projects in Bhutan and Bangladesh viz. (a) Bhutan – Turnkey project for dismantling existing sub-station and design, engineering, construction, supply, erection, testing and commissioning of sub-station at Paro; and (b) Bangladesh - Construction of 2nd Bhairab Railway Bridge.

The Company has also completed two projects in India viz. contract KT-4 for ballastless track of standard gauge in elevated section of Aluva to Petta corridor and contract KT-5R1 for standard gauge track work in Muttom Depot of Kochi Metro Rail Limited.



## **ORDER BOOK**

The Company has secured new works worth Rs. 6,030 crore during the year, taking the work load to Rs. 18,878 crore as on 31st March 2017. Works secured after the close of the year, has taken the work load to Rs. 20,010 crore as on 30th June 2017.

## **CSR & SUSTAINABILITY**

The Company has spent a total amount of Rs. 5.89 crore towards Corporate Social Responsibility (CSR) initiatives, broadly comprising of activities in the field of health, education, rural development, environment, facilities for differently abled, employment enhancing education, and Infrastructure development.

## **SUBSIDIARIES AND JOINT VENTURE COMPANIES**

During the year, the Company formed a joint venture company called 'Bastar Railway Private Limited' (BRPL), incorporated on 5th May 2016, to implement coal connectivity projects in the State of Chhattisgarh with equity participation of 26% by Ircon.

After the close of the year, one wholly-owned subsidiary company by the name 'Ircon Davanagere Haveri Highway Limited' (IrconDHHL) was formed on 11th May 2017 to undertake the business of development, maintenance and management of National Highway No. 48 (Old NH-4).

Further, during the year the Company has divested its stake in following Companies:

- i) 25% in the Companhia Dos Caminhos De Ferro Da Beira SA (CCFB), a JVC formed for execution of Beira Rail Concession Project in Mozambique, consequent upon receipt of payment in terms of Settlement Agreement dated 21st October 2015 with Government of Mozambique in respect of dispute regarding termination of Concession.
- ii) Transferred 1% equity stake of Indian Railway Stations Development Corporation Limited (IRSDC) (out of 51% held by Ircon to RLDA) so as to

make IRSDC a 50:50 JV Company in terms of Ministry of Railways letter dated 10.04.2017.

With these additions/ disinvestments, Ircon Group now comprises four subsidiaries (viz. Ircon Infrastructure & Services Limited, Ircon PB Tollway Limited, Ircon Shivpuri Guna Tollway Limited and Ircon Davanagere Haveri Highway Limited) and seven JVCs in India (viz. Ircon-Soma Tollway Private Limited, Indian Railway Stations Development Corporation Limited, Chhattisgarh East Railway Limited, , Chhattisgarh East-West Railway Limited, Mahanadi Coal Railway Limited, Jharkhand Central Railway Limited, and Bastar Railway Private Limited).

**Financial Profile**

During 2016-17, Ircon has achieved turnover of Rs. 3254 crore, which is higher by 14% and profit before tax of Rs. 532 crore, which is lower by 12% as compared to previous financial year. The decline had been on account of substantial income recognized on settlement agreement with Government of Mozambique during 2015-16.

Ircon has paid a total dividend of Rs. 192.40 crore @ 550% of the paid-up share capital, which works out to 52.15% of post-tax profits for 2016-17.

## 2.0 Implementation of the RTI Act.2005 & Procedures Followed

IRCON as per the records available in the RTI cell, had started the implementation of the RTI Act 2005 immediately after the enactment of the RTI Act in 2005. As per the records the company had nominated the Appellate Authority (AA), Central Public Information Officer (CPIO) & State Level( Regional) Public Information Officer (PIO) during the year 2005 and also notified the same on their website.

As per the system being followed for the implementation of the act in IRCON, there is one centralise monitoring cell at Corporate Office, under the General Manager (Civil). In addition there are 4 State (Regional) Level Public Information Officers responsible for four regions. There is one APIO assisting to CPIO at corporate Centre. It is having one centralised Appellate Authority for all business unit heads , Corporate, State & Regional offices .

However, correspondence or information to the applicant is being provided by respective PIO or State ( Regional ) Level Information Officers.

Appellate Authority (AA) is independently receiving the appeals related to all the regions or departments/business unit and disposing of the same in line with the provisions in the act within 30 days except in some exceptional cases.

### **4.0 Compliance of RTI act in IRCON (Compliance of Section 4(1)(b))**

In accordance with the RTI Act 2005, it was the obligations of all the public authorities to comply with the provisions of the section 4(1) (b) on proactive disclosures and to publish the same within 120 days from 15-06-2005 i.e. from the date of enactment, for smooth implementation of the RTI act from the date of enactment that from 12-10-2005. IRCON had to proactively disclose all the information as mentioned in 17 paras i.e.(a) i to xvii, of section 4 of the RTI Act. IRCON has presently provided data/details/ information with respect to 15 points on their website except for 2(Two ) items , which are not applicable to IRCON. Detailed clause wise status is given in the **Annexure II**.

### **5.0 Details for obtaining of information by citizen of India**

As per the RTI Act , clause 4(1)(b)(xv) detailed procedure has to be mentioned by all public authorities for obtaining information by the citizen of India . IRCON being the public authority has provided the procedure for obtaining information by the citizen under RTI portal, including particulars & Contact details of CPIO/STATE( Regional) LEVEL PIO AND APIO.

For making FIRST appeal as per section 19 of the act, IRCON has also provided the complete details of the Appellate Authority along with his official contact details.

### **6.0 Acceptance of cash by IRCON for RTI Fee**

IRCON is accepting cash against application fee as well as for additional fee for providing information, as per the RTI act Fee Rules, 2005.

### 7.0 Compliance of Section 4(1) (a)

Detailed discussions were held with heads of three departments for implementation of the act & compliance of the section 4(1) with respect maintaining of the records. We contacted three departments i.e. RTI Cell, Civil Division and the Legal & Arbitration Cell.

All the three departments' have confirmed for maintaining the proper records management in their respective departments for faster retrieving of the information and providing the same to the concerned PIO. For RTI cell there is separate record retention policy in place as per circular dated 26-07-2016.

It has been told that all the departments are ISO Certified, and the ISO procedures are being followed in decision making process & with respect to the retention of the documents and weed out of the same as per the life of documents mentioned in the respective procedures which are being followed. Computerisation of the documents & records indexing & cataloguing are under consideration.

### 8.0 Suo-motu disclosures under section 4(2), 4(3) & 4(4)

IRCON as per requirement of Suo-motu disclosures under 4(2), 4(3) & 4(4) has provided adequate information on the web site as well as in their annual report. In addition to this, details of all type of projects being executed or under execution in India or globally have also been given on the website. IRCON has also shared information about domestic & global markets, future plans, annual report covering all the financial parameters, operational highlights, order book positions, awards etc etc.

As per the records physically seen related to the Quarterly Reports of IRCON , they are regularly submitting quarterly reports to CIC, in the prescribed Performa of DoPT. (Quarterly Reports for all the four quarters for the year 2016-17 are enclosed at Annexure III, Quarterly Reports are being collected by the RTI Cell from the four state (Regional) level PIOs , records for those is available with the RTI Cell. Based on these reports consolidated single report is being prepared and forwarded to the concerned authorities by centralised RTI Cell under the CPIO.

**13.0 Training on RTI (Section 26 ) & OM dated 24-06-2008**

IRCON is time to time deputing its officers for RTI Programs & Seminars. It was suggested to have in house training on RTI for creating awareness as per section 26 of the RTI Act & OM dated 24-06-2008. IRCON have also conducted two half day programs for the officials of the Corporate Office.It is necessary as all the officers, who are custodians of the information, must have awareness about the provisions of the act in order to implement in right spirit to provide information within 30 days.



**14.0 Update of information (Section 4 (xvii))**

IRCON has confirmed that, it is updating the information every year & as and when required. Presently, updated information is available on the website as on 05-07-2018.

**15.0 Update of Replies on Website**

Regarding Update of RTI replies on website, IRCON is uploading the RTI replies on the website in order to comply with the DoPT Circular No. 1/1/2013-IR, Dated: 21-10-2014. All the replies of CPIO & orders FAA are available on the website of IRCON under the portal of RTI.

**16.0 Availability of latest circulars, guidelines and notifications on RTI**

IRCON is maintaining now all the important circulars/ guidelines in the separate file for day to day references.

**17.0 CITIZEN CHARTER**

IRCON has published the information regarding citizen charter on the website as per DoPT Circular dated 15-04-2013.

**18.0 PPP CONTRACTS/ AGREEMENTS**

IRCON has to publish the information regarding PPP contracts/Agreements on the website as per DoPT Circular dated 15-04-2013. Presently IRCON is not having any such agreement/ assignments.

**19.0 PROCUREMENTS /BID AWARDS**

IRCON has to publish the information regarding contracts/bid awards on the website as per DoPT Circular dated 15-04-2013. IRCON, is putting the information related to procurement giving complete details of the awards such as name of the contractor and value.

**20.0 CAG & PAC PARA**

IRCON have included the CAG & PAC para in their annual report, which is available on the web site of the company. **Annexure IV**

**21.0 RTI PARA IN ANNUAL REPORT CIRCULAR 15-04-2013**

IRCON in their Annual Report have included a para on implementation of RTI Act 2005 as per provision of the DoPT circular of 15-04-2013, **Annexure V.**

**22.0 Transfer Policy & Transfer Orders**

The transfer policy of employees is available on the website of IRCON, however, the transfer orders are being put on the intranet of IRCON, which is available only to the employees. In case any applicant seeking for the specific transfer order of the employee is being provided as per the provision under the act after applying the section 8 of the RTI Act 2005 if applicable.

**23.0 Examination/ Audit of CPIO office/FAAoffice/ APIO office/ State Level PIO Office**

Detailed discussions were held in the office of Mr. Masood Ahmad GM.(Civil) & CPIO on 12-07-2018 along with Mr. P. Likhari Asstt. Manager, RTI Cell with respect to implementation of RTI Act in IRCON. Also examined the process of Information availability, records of documents, availability of relevant circulars /guidelines, training of officers on RTI etc.

Detailed discussions were held in the office of Mr. Bhupesh Kumar Thakur, State Level PIO, (North) on 12-07-2018 with respect to implementation of RTI Act & legal vetting process of RTI Reply in North Region. It was observed that record maintenance of the RTI application by the regions are different than the Corporate RTI Cell. RTI Cell is maintaining the records in a very systematic manner. It was advised that to maintain the consistency all the regions follow the same pattern, CPIO has already issued circular in this regards, but compliance of the same is awaited from the respective regions.

Detailed discussions were held in the office of Mr. S.L.Gupta, Executive Directors & Appellate Authority on 16-07-2018 with respect to implementation of RTI Act & Appeal disposal process in IRCON.



All the concerned documents, registers, files, website of IRCON including RTI Portal were examined /audited and detailed observations are given below;

**24.0 OBSERVATIONS;**

On examinations of records of replies & information provided to the applicants it has been found that consistently IRCON is providing information or making replies to the applicants within 30 days for 100% applications.

On examinations of records of appeals filed by applicants to the First Appellate Authority examined by me, it has been found that consistently the Appellate Authority is disposing of the appeals within 30 days. No case has been found where appeal was dispose of beyond 30 days.

IRCON has complied the obligations of public authority by pro active disclosures of the information as per section 4(1) (b) of the RTI Act , detailed status is given in the attached **annexure II**.

As well as, IRCON is sharing the information regularly through newsletters/ intranet and internet. However, certain minor deficiencies have been observed that needs to be complied during the next update or at the earliest.

Regarding Update of RTI replies on Web site -IRCON is uploading of the RTI replies in order to comply the DoPT circular No. 1/1/2013-IR, Dated: 21-10-2014.

Proper guidelines from Corporate Office for implementation of the RTI Act 2005 at its State Level offices has been issued as recommended earlier. It is suggested to obtain the compliance of the same from the regions.

IRCON time to time deputing its officers for RTI Programs & Seminars. It was suggested to have in house training on RTI for creating awareness as per section 26 of the RTI Act & OM dated 24-06-2008 . IRCON have also conducted two half day in-house programs for the officials of the Corporate Office. More awareness programs including for its regional officers needs to be conducted.

RTI Cell is maintaining the records in a very systematic manner. It was advised that to maintain the consistency all the regions follow the same pattern.

**25.0 FINAL CONCLUSIONS / RECOMMENDATION TO IRCON**

IRCON implementing RTI ACT 2005 in right and true spirit may be seen from the status of applications and appeals that all 100 % of the applications have been disposed of by CPIO within the time limit of 30 days..

Also all the first appeals were disposed of by the appellate authorities within 30 days.

To conduct more RTI Training Program for the awareness of all employees including all regions ,which shall also help in faster processing of RTI application and shall save the administrative time of the company.

It was advised that to maintain the consistency in maintaining of the receipts & dispatch registers in all the regions must follow the same pattern. It is suggested to obtain the compliance of the circular issued by CPIO to the regions.

**26.0 Certification**

In view of the above, it is concluded that IRCON is meeting the most of the requirements of the provisions of RTI act i.e. the major compliance for section 4 (1)(b) as well as, providing the information against all the RTI applications within stipulated time of 30 days and all the appeals have also been disposed of within stipulated time of 30 days. Therefore, IRCON has complied the RTI audit requirements of the section 4(1)(B) & requirements of the DoPT Circular dated 15-04-2013.

The preparation of consolidated financial statements of IRCON International Limited for the year ended 31 March 2017 in accordance with the financial reporting framework prescribed under the Companies Act, 2013 is the responsibility of the management of the company. The Statutory Auditors appointed by the Comptroller and Auditor General of India under Section 139 (5) read with section 129(4) of the Act are responsible for expressing opinion on the financial statements under Section 143 read with section 129(4) of the Act based on independent audit in accordance with the standards on auditing prescribed under section 143(10) of the Act. This is stated to have been done by them vide their Audit Report dated 21 September 2017.

I, on behalf of the Comptroller and Auditor General of India, have conducted a supplementary audit under section 143(6)(a) read with section 129(4) of the Act of the consolidated financial statements of IRCON International Limited for the year ended 31 March 2017. We did not conduct supplementary audit of the financial statements of Subsidiaries and Jointly Controlled Entities (as per Annexure) for the year ended on that date. Further, section 139(5) and 143 (6)(b) of the Act are not applicable to Companhia Dos Caminhos De Ferro De Beira, SA being private entities incorporated in Foreign country under the respective laws, for appointment of their Statutory Auditor nor for conduct of supplementary audit. Accordingly, C&AG has neither appointed the Statutory Auditors nor conducted the supplementary audit of these companies. This supplementary audit has been carried out independently without access to the working papers of the statutory auditors and is limited primarily to inquiries of the statutory auditors and company personnel and a selective examination of some of the accounting records.

On the basis of my audit nothing significant has come to my knowledge which would give rise to any comment upon or supplement to statutory auditors' report.
