2. **Age criteria** – Age should be below 63 years as on 01.06.2016.*

*Working Professionals are also eligible to apply in case they take voluntary retirement from their organizations and wish to join Ircon on service contract basis. In such cases their emoluments will be calculated on the same basis as per the retired employees who will be re-engaged on service contract basis.

Experience – Experience in Construction will be preferred.

Duration of the Service Contract – Duration of Service Contract will be initially for 1 year, further extendable till duration the project or attaining the age of 65 years of the officer whichever is earlier.

3. Consolidated lumpsum payment per month will be calculated as per formula below:-
