Sub: Disclosure under Regulation 30 of SEBI (LODR) Regulations, 2015- Imposition of fine by NSE & BSE for the quarter ended 30th June, 2023

Dear Sir/ Madam, महोदय /महोदया,

Pursuant to Regulation 30 read with Para-A of Part-A of Schedule-III of the SEBI (LODR) Regulations, 2015, it is to inform that National Stock Exchange of India Limited (NSE) and BSE Limited (BSE) vide their letters dated 21st August, 2023 have levied fine of Rs.5,36,900 each (incl. GST) on the Company for the non-compliance with Regulation-17(1) i.e., half of the Board was not independent, for the quarter ended 30th June, 2023.

The Company, vide its letter dated 22nd August, 2023, has clarified to NSE and BSE that Ircon International Limited (IRCON) is a government company as per provisions of the Section 2(45) of the Companies Act, 2013. As per provisions of the Companies Act, 2013 and Articles of Association of the Company, the President of India vests with the power to appoint Directors (including Independent Director) on the Board of IRCON. All Directors in IRCON are appointed by the Government of India through its Administrative Ministry, Ministry of Railways (MoR) and IRCON has no role to play in the appointment of any Director unless nominated by the Government of India.

The fine levied by NSE and BSE has no impact on the financial, operation or other activities of the Company.
