 - c) Self-Attested copy of GATE 2015/2016 registration number & score card.
 - d) Certificates of other professional qualifications, if any;
 - e) Certificates in proof of experience, if any, as applicable, clearly projecting the requisite experience indicating the length and line of experience as per eligibility conditions/criteria;
 - f) Certificate in support of claim of belonging to Schedule Caste, Schedule Tribe and Other Backward Classes, Ex-serviceman, where applicable.
 - g) **If the candidate belongs to OBC**, a caste certificate issued in the current financial year only by a competent authority as applicable for appointment to the services in Govt. Of India. Please

- note, that an OBC certificate issued in the current financial year only can be accepted as a current proof of your not belonging to "creamy layer" in the OBC.
- h) No Objection Certificate (NOC) from present employer if working in Govt./PSU's/Autonomous bodies
- i) One Photo-identity-card like Driving-license, Passport or any other valid document with you for identification &
- j) Complete set of self-attested photocopies of all the above mentioned certificates
- V.
