केंद्र को रिजर्व बैंक से मिलेगी 57,128 करोड़ की अधिशेष रकम

नई दिल्ली, 14 अगस्त (भाषा)।

भारतीय रिजर्व बैंक के केंद्रीय बोर्ड ने लेखा वर्ष 2019-20 के लिए केंद्र सरकार को 57,128 करोड़ रुपए का अधिशेष हस्तांतरित करने की मंजूरी दे दी है। इसके अलावा बोर्ड ने आपात जोखिम बफर को 5.5 फीसद पर कायम रखने का फैसला किया है। रिजर्व बैंक के एक बयान के अनुसार गवर्नर शक्तिकांत दास की अगुआई में शुक्रवार को हुई बोर्ड की बैठक में यह फैसला किया गया। यह बैठक वीडियो कॉन्फ्रेंस के जरिए हुई। यह केंद्रीय बोर्ड की 54वीं बैठक थी। बोर्ड की बैठक में मौजूदा आर्थिक स्थिति, वैश्विक और घरेलू चुनौतियों तथा केंद्रीय बैंक द्वारा कोविड-19 के आर्थिक प्रभाव से उबरने के लिए किए गए मौद्रिक, नियामकीय और अन्य उपायों की समीक्षा की गई।

रिजर्व बैंक की ओर से जारी बयान में कहा गया है कि केंद्रीय बोर्ड ने नवोन्मेषण केंद्र स्थापित करने के प्रस्ताव पर भी विचार-विमर्श किया। बोर्ड ने

पिछले साल के दौरान केंद्रीय बैंक के विभिन्न परिचालन क्षेत्रों की स्थिति की समीक्षा की और रिजर्व बैंक की 2019-20 के लिए वार्षिक रिपोर्ट तथा लेखा-जोखा को भी मंजूरी दे दी।

इस बैठक में रिजर्व बैंक के डिप्टी गवर्नर की पी कानुंगो, महेश कुमार जैन, डॉ. माइकल देवव्रत पात्रा तथा केंद्रीय बोर्ड के अन्य निदेशक एन चंद्रशेखरन, अशोक गुलाटी, मनीष सभरवाल, प्रसन्ना कुमार मोहंती, दिलीप एस सांघवी, सतीश के मराटे, एस गुरुमूर्ति, रेवती अय्यर और प्रोफेसर सचिन चतुर्वेदी भी शामिल हुए। बैठक में आर्थिक मामलों के विभाग के सचिव तरण बजाज तथा वित्तीय सेवा विभाग के सचिव देवाशीष पांडा ने भी भाग लिया।

नकारात्मक हुई जुलाई में थोक महंगाई खाद्य पदार्थों के दाम बढ़े

नई दिल्ली, 14 अगस्त (भाषा)।

थोक कीमतों पर आधारित महंगाई की दर जुलाई में शून्य से 0.58 फीसद नीचे रही। इस दौरान खाद्य पदार्थों की कीमतों में बढ़ोतरी देखी गई जिससे थोक मुद्रास्फीति पिछले माह से ऊंची हुई। थोक मुद्रास्फीति जून में शून्य से 1.81 फीसद नीचे, जबकि मई और अप्रैल में यह क्रम से शून्य से 3.37 फीसद और शून्य से 1.57 फीसद नीचे थी। थोक मूल्य सूचकांक (डब्ल्यूआई) मुद्रास्फीति पिछले चार महीनों से शून्य से नीचे है। इसके शून्य से नीचे होने का अर्थ है कि सामान्य कीमतें पिछले साल की तुलना में घटी हैं।

वाणिज्य और उद्योग मंत्रालय ने शुक्रवार को जारी बयान में कहा कि मासिक डब्ल्यूआई पर आधारित मुद्रास्फीति की वार्षिक दर जुलाई, 2020 में शून्य से 0.58 (अंतिम) फीसद नीचे रही, जो पिछले साल की समान अवधि में 1.17 फीसद थी। खाद्य वस्तुओं की महंगाई जुलाई के दौरान 4.08 फीसद थी, जो चार महीने का उच्चतम स्तर है। इस दौरान खासतौर से सब्जियों के दाम में तेजी देखने को मिली। सब्जियों की महंगाई दर जुलाई में 8.20 फीसद थी, जबकि जून में सब्जियों का भाव एक साल पहले की तुलना

में 9.21 फीसद नीचे था। इस दौरान दलहन की कीमतों में 10.24 फीसद का इजाफा हुआ, जबकि आलू जुलाई में 69.07 फीसद महंगा हुआ। प्रोटीन की बहुलता वाले खाद्य पदार्थों जैसे अंडा, मीठ और मछली की कीमतों में 5.27 फीसद की बढ़ोतरी हुई। हालांकि, प्याज और फल सस्ते हुए।

हालांकि, जुलाई में ईंधन और बिजली की मुद्रास्फीति (-) 9.84 फीसद रह गई, जो इससे पिछले महीने शून्य से 13.60 फीसद नीचे थी। विनिर्मित उत्पादों की मुद्रास्फीति में 0.51 फीसद थी, जो जून में 0.08 फीसद थी। आइसीआरए की प्रधान अर्थशास्त्री अदिति नायर ने कहा कि पिछले महीने की तुलना में जुलाई 2020 में डब्ल्यूआई अवस्फीति में काफी कमी हुई है और ऐसा कच्चे तेल के साथ ही खाद्य वस्तुओं की कीमतों में तेजी के चलते हुआ है। उन्होंने कहा कि टमाटर की कीमतों में बढ़ोतरी दो अंकों में रही, जबकि खाद्यान्न की मुद्रास्फीति में राहत देखने को मिली। आरबीआई ने पिछले हफ्ते अपनी नीतिगत समीक्षा में ब्याज दरों को अपरिवर्तित रखते हुए कहा था कि मुद्रास्फीति का जोखिम बना हुआ है। केंद्रीय बैंक का अनुमान है कि अक्टूबर-मार्च की अवधि में खुदरा मुद्रास्फीति कुछ नरम पड़ेगी।

लाल किले से लगातार सातवीं बार देश को संबोधित करेंगे प्रधानमंत्री

इस बार सुरक्षा कार्यों से किसी को भी कोरोना का लक्षण होने पर समारोह में जाने से रोका जा सकता है। सुरक्षा जांच के साथ ही तापीय परीक्षण भी किया जाएगा। पहली बार ऐसा है कि प्रधानमंत्री को सलामी देने वाले गार्ड के जवानों के स्वास्थ्य जांच के बाद पहले से ही पृथक आवास में रखा गया है। समारोह में तैनात जवान फेस शील्ड, मास्क, दस्ताने पहने होंगे। पीपीई किट में भी कुछ जवान तैनात होंगे। इस बार कम अतिथियों को बुलाया गया है। जहां पहले 600 से 700 मेहमान समारोह में बुलाए जाते थे वहीं इस बार इनकी संख्या 125, 150 के बीच रहेगी। इसके अलावा इस बार कोरोना योद्धा भी बुलाए गए हैं। इस बार तिरंगे परिधान में तिरंगे के आकार में बैठने वाले स्कूली बच्चे भी नहीं होंगे। इनकी जगह करीब 500 एनसीसी केडेट बुलाए गए हैं।
