

Vide your letter dated 11.04.2016 addressed to CMD/IRCON, you have requested that company may deduct 50% salary of Shri Varun Kumar Singh, AM/Civil and forward the same to you as Sh. Earlier also vide your letter dated 07.01.2015, you made a representation and requested for action against Shri Varun Kumar Singh since he and his parents have demanded dowry. Based on your representation, an explanation was called from Shri Varun Kumar Singh wherein he defended his position and stated that the case is under consideration on Hon'ble Court.

In view of the above, IRCON cannot deduct any portion of salary of Sh. Varun Kumar Singh and also initiate any action against him unless there is any direction from the competent court.
