#### **ORDER**

Sub: Appeal of Shri Amit Bhardwaj dated 26.07.2016 under RTI Act, 2005

#### Present:

1. Shri Amit Bhardwaj filed an RTI application dated 06.06.2016 seeking information on various issues related to deployment of safety officers & staff on various Ircon project offices, their sanctioned strength and vacant posts, essential qualifications for these posts, status of welfare department in Ircon, method of fixation of salary of contractual employees, benefits being given to contractual employees, details of contractual employees who have been regularized, status of disaster management plan in Ircon, responsibility of the persons to check the quality of Personal Protective equipments, details of complaint authority, responsibility of Ircon for conducting survey before start of new project, how many and which safety staff has been given refresher/induction training, how many safety mock Drills have been conducted by Ircon, details of para-medical staff, list of Ircon Projects in India and abroad.

- 2. Applicant was provided information by CPIO vide letter dated 13.07.2016. Being not satisfied with the information supplied by CPIO, he filed an appeal vide letter dated 26.07.2016 which was received in Ircon on the same date.
- 3. Shri Amit Bhardwaj attended the office of Appellate Authority on 09.08.2016 for personal hearing. One-by-one each question was raised by Shri Amit Bhardwaj and he was explained the status of Ircon on each issue. Applicant was also explained that as per the scope of RTI Act, Appellate Authority can only provide him the information as available on record. Under RTI, suggestions, opinion cannot be discussed. Applicant was harping that what action has been taken by Ircon for safety of the staff posted on the projects, and we should discussed after taking into account the contract conditions of the projects. Applicant was explained that he can seek the copy of contract conditions but at the RTI forum we cannot discuss the contract conditions viz-a-viz the Act, responsibilities, liabilities, etc. At last, he requested that a list of projects which has been supplied to him may be segregated in the type of projects viz. Civil, Electrical, Mechanical, etc.

- 4. CPIO is directed that he may segregate the list of projects supplied to the applicant as Civil, Electrical, Mechanical, S&T, etc.
- 5. Appeal is disposed of.
