II. Juxta position of the information sought by the applicant and the reply of deemed PIO is as under:-

(1) The applicant has sought the following documents:

"All documents submitted by M/s. SRC Company Infra Pvt. Ltd. in support of fulfilling of qualification criteria for the tender of Construction of private railway siding with all contractors materials (except rails for plain track issued free of cost) for coal transportation system for Darlipali STPP of NTPC Limited in Sundergarh Distt. in Odisha State - from Ch.6.00 to Ch.12.460 - Pkg.I in Darlipali-Dulanga MGR Section - Tender No.IRCON/2061/Darlipali/Site works/Pkg.1/04".

(2) The applicant is informed that he has sought third party information, which is the personal property of M/s. SRC Company Infra Pvt. Ltd. and disclosure of which may harm the competitive position of 3rd party in future tenders. This also does not warrant any public interest in accordance with Section 8(1)(d) of the RTI Act. Hence, it does not justify for disclosure of such information. The relevant Section is reproduced below for information.

"Section 8(1)(d): Information including commercial confidence, trade secrets or intellectual property, the disclosure of which would harm the competitive position of a third party, unless the competent authority is satisfied that larger public interest warrants the disclosure of such information."


