II. Ground of Appeal:

Applicant has made an appeal on the grounds that he may be supplied a copy of Ircon's letter dated 24.02.2015. In the subsequent paragraphs he has raised various grievances and sought replies to his queries.

III. Discussion:

- 1. CPIO while disposing his application on 22.08.2016 informed that letter dated 24.02.2015 was supplied by CPIO along with his letter dated 02.12.2015.
