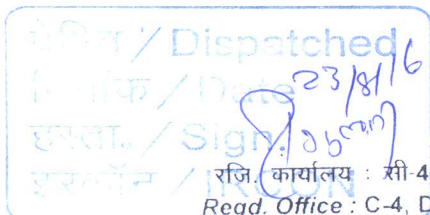




IV. **Decision:** Application is disposed of.
