  - Allowances of Medical, LTC, Child Education, Marriage of Sister's, paid by you
  - Transfers orders, his joining dates, given traveling charges & gifts by you. And his official visit to New Delhi from his unit office Ramagundam details provide.
  - My father was employee as regular basis/temporary/adhoc/casual/daily/ labour/etc.
  - The contribution made by my father & you for EPF/GPF, EPS1995 / Railway pension 1993, Union of Ircon employees, Income Tax, other funds.
  - The membership number / ID allotted to him for above.
  - My father death occurred details, the persons joined him Safdarjung Hospital, Ircon Officers given Press Notes.
  - As per employment standing orders 1946, the certificate given on his death to his legal heirs @Ircon Office / through postal service.

- (x) The detailed benefits paid by IRCON after my Father's death & the papers of signed documents by my mother.
  - (xi) The seniority of my father in Ircon & his promotions get with Ircon employees promotions rules, regulations.
  - (xii) The widow pension giving to my mother is Govt. Pension or Pvt. /Contributory.
  - (xiii) The applications made by my father for benefits & Ircon granted papers zeroes.
  - (xiv) The O.T's & shift-wise duty allotted to him, the attendance record of my father, from appointment to till the death.
3. The employee of Ircon comes under Central Govt. Railway employees or Public Servant or Undertaking Semi Govt.
  4. The Govt. Undertaking means, Railway undertaking means.
  5. The mandatory payments made at employees on retire, VRS, retrenchment, terminate, superannuation, death cases.
  6. The death employees in Ircon while in service.
  7. The safety measures taken by Ircon to employees.
  8. The responsibility of Ircon on deceased / deceased employee.
  9. From establishment to till the rules & regulations, Act, manuals, etc. made & amended, repealed in Ircon.
  10. The BOD/MD/Shareholders Meetings, taken decisions on employee recruit/retire/death/compassionate ground jobs, facilities to them & workers.
  11. As per the labour acts Ircon taken steps to workers/employees
  12. The action on my RTI letter to Ircon MD & CPIO sent through CPIO O.O. Hon'ble Prime Minister of India.
  13. The inward-outward register 2003-Jan 1<sup>st</sup> to 2003 May 31<sup>st</sup> & letters 2003-2015.

III. **Discussions:**

1. Applicant has sought various information related to her father late Shri S. Shankaraih, Messenger like joining date, appointment letter, agreement copies, ID Card, Service book, details of increment, Bonus, Leave, Allowances - Medical, LTC, Child Education, EPF/GPF, details of Transfers, etc. She has further asked the public authority to explain what is the meaning of Govt. Undertaking, Railway Undertaking, responsibility of Ircon on diseased employees, decisions taken by BoD, copies of inward/outward register from 2003 to 2015, etc.

2. Earlier Shri S. Srinivas, Son of late Shri S. Shankaraiah sought similar information through 12 applications/appeals under RTI during the period from 2012 to 2015. He not only addressed these applications to Ircon but sought the similar information under RTI from Ministry of Railways, Ministry of Labour & National Human Rights Commission. The information sought from Ministries was forwarded to Ircon for final disposal. All these applications/appeals have been disposed of.

In addition mother of Shri S. Srinivas made representations to Ircon, Ministry of Railways, Minister of commerce & Industries and Minister of Labour & Employment. All these representations have been replied by HR department.



3. The information sought by the applicant is wide & vague. Under RTI Public authority is not to educate the applicant and give his opinions / suggestions. In view of this, information sought by the applicant cannot be supplied. However, the applicant, if so desired, can seek copies of information supplied to Shri S. Srinivas, as mentioned in (2) above, covering the issues raised by her. For obtaining copies replies, supplied to Shri S. Srinivas, she is required to deposit an additional fees of Rs.66/- (Rupees sixty six only) by way of cash against proper receipt or by Demand Draft or Banker's cheque or Indian Postal Order payable to Ircon International Limited.

IV. **Decision:**


The information sought by the applicant is wide & vague, hence cannot be provide in terms of Section 7(9) of RTI Act.
