II. Grounds of Appeal:

Applicant has made an appeal on the grounds that the action of the Jammu project office for returning his RTI application is not correct. As per RTI Act, Jammu project office of Ircon should have forwarded his RTI application to the appropriate authority with the intimation to the applicant. Since the applicant has not received the reply within 30 days of making the application, he has filed an appeal under RTI Act for seeking information.

III. Decision:

The grounds of appeal of the Applicant are noted. Action is being taken in-house to avoid such instances. Application of the applicant is being forwarded to PIO/North, the appropriate authority to supply the information to the applicant within 7 days from the date of issue of this Order. PIO/North is also advised that information may be supplied to the applicant free of cost without additional fees, if any.
