II. Applicant has sought the following information:

1. I request you that in spite of several approaches in person or in writing no action is taken by Ircon to release my arrear money arisen out of 6<sup>th</sup> pay commission though I was retrenched from service in Feb. 1998. In spite of Hon'ble Allahabad High Court Order, Ircon did not care to release my above payment (under refe.II) copy enclosed)
2. Please pay my above dues and also inform under circumstance this above payment is not paid till date at the earliest.

III. **Discussions:**

1. In Para 1, applicant has raised his grievance and no information has been sought. For redressal of grievance, applicant may approach the Management of Ircon and not to the public Authority under RTI Act.
2. Regarding Item No.2 of Para II above, applicant is dictating instructions and seeking explanation of the Public Authority stating that dues may be paid and inform under what circumstance the payment is not made till date. Public Authority in the case of RTI is responsible to supply the information sought by the applicant and not to submit explanation or replies to the queries raised by the applicant. In this connection, applicant is advised to refer Section 2(f) of RTI Act, which is extracted as under:
