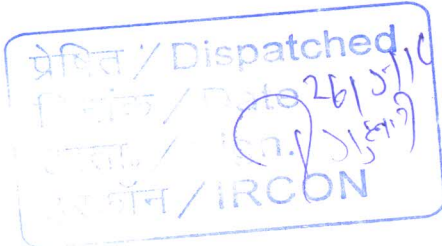


**II. Decision:**
