**II. Grounds of Appeal**

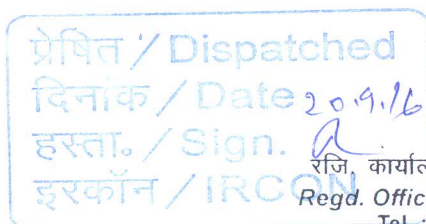
Applicant has made an appeal on the grounds that none of the questions have been answered and ignore deliberately. He has further requested that Appellate Authority should look into the matter as he sense some irregularities in the functioning of the system. He has emphasized he personally feel that Govt. of India's money has been compromised big time and has requested for effective action on the same.

**III. Decision**

I have perused the application of the applicant seeking information under RTI Act and the reply of the CPIO while disposing of the said application. CPIO has supplied the information which could be supplied. CPIO has justified quoting the relevant sections of RTI Act under which the information cannot be supplied. I don't find any justified reason to interfere with the communication of CPIO. Hence I support the stand taken by CPIO.

**IV. Appeal**

If applicant is not satisfied with the decision of the First Appellate Authority, he can file an Appeal to the 2<sup>nd</sup> Appellate Authority within 90 days of the issue of this letter in terms of Section 19(3) of the Right to Information Act, 2005. 
