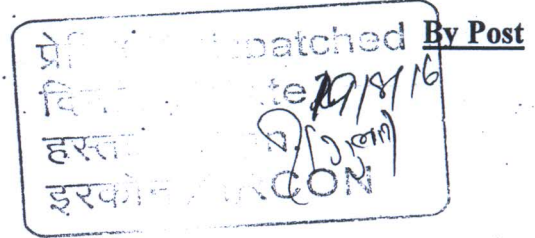

III. **Decision:**


Information sought by the applicant under Item No. (1) to (3) of the application dated 29.07.2015 is supplied.
