ORDER

I. Background and facts of cases

1. Date-wise events:

Date of Application : 19.07.2016
Date of receipt of application : 05.08.2016 (Through CPIO/IRCON)

2. Juxta position of the information sought by the applicant and the reply of deemed PIO is as under:-

Sl. No.	Information required by the applicant	Information given by the deemed PIO
1.	"I request you that in spite of several approaches in person or in writing no action is taken by IRCON to release my arrear money arised out of 6 th pay commission through I was retrenched from service in February, 1998. In spite of Hon'ble Allahabad High Court order (copy enclosed), IRCON did not care to release my above payment. Please pay my above dues and also inform under what circumstance the above payment is not paid till date at the earliest."	In connection with settlement payment to abide by Hon'ble Allahabad High Court's Order & other payments, a total amount of Rs.3,00,000.00 has been paid to the applicant vide D.D. No.899762 dated 23.03.2002 along with other ex-employees of Anpara Project, retrenched on 06.02.1998. The break-up of the above amount is as below:- i) EPF amount = Rs.87,889/- ii) Arrear due to revision in IDA scale = Rs.22,525/- iii) Leave Salary = Rs.6,008/- iv) Gratuity = Rs.17,918/- v) Ex-Gratia Compensation Rs.1,65,660/- Being in IDA scale, nothing is payable due to revision of 6 th Pay Commission. Hence, the applicant has already been paid full & final settlement dues of Rs.3.00 lakhs, which includes Pay Commission arrear & all other statutory payments. Therefore, no due is left to be paid to the applicant. In this regard, copy of confirmation by IRCON along with acknowledgement of receipt of above payment by the applicant towards full & final settlement is enclosed.

II. **Discussion**

Shri Shyam Sunder Vishwakarma has enclosed a copy of Hon'ble Allahabad High Court's order dated 01.08.2002 against Case No.30999 of 2002 in which his name has not appeared as one of the Petitioners and therefore, the same is not relevant to his case. Moreover, since Sri Vishwakarma was in IDA Scale, arrear based on 6th Pay Commission Report as referred in his application, was not applicable to him. However, necessary arrear based on Pay Commission Report for IDA Scale, has already been paid to him along with his full & final settlement dues as detailed above. Thus, IRCON has taken due care in releasing his legitimate dues, whereas the applicant has made unjustified claim.


III. **Decision**
