In connection with settlement payment to abide by Hon'ble Allahabad High Court's Order & other payments, a total amount of Rs.3,00,000.00 has been paid to the applicant vide D.D. No.899196 dated 15.03.2002 along with other ex-employees of Anpara Project, retrenched on 06.02.1998. The break-up of the above amount is as below:- i) EPF amount = Rs.87,070/- ii) CDA arrear = Rs.2,234/- (Total amount=Rs.7,234.00-Rs.5,000.00 paid as advance) iii) Leave Salary = Rs.108/- iv) Gratuity = Rs.31,473/- v) GSLI = Rs.40/- vi) Ex-Gratia Compensation Rs.1,79,075/- Hence, the applicant has already been paid full & final settlement dues of Rs.3.00 lakhs, which includes Pay Commission arrear & all other statutory payments. Therefore, no due is left to be paid to the applicant. (1) Applicant has sought the following information enclosing therewith a copy of Hon'ble High Court, Allahabad Order dated 01.08.2002 in civil Writ Petition No.30999 of 2002 – Suryamani and others Verses Ircon International Ltd.

“I request you that in spite of several approaches in person or in writing no action is taken by IRCON to release my arrear money arised out of 6th pay commission throught I was retrenched from service in Feb. 1998. In spite Hon'ble Allahabad High Court Order IRCON did not care to release my above payment.”

(2) Applicant is informed that he was not a party in Civil Writ Petition No.30999 of 2002 – Suryamani and others Verses Ircon International Ltd. However, the directions of the Hon'ble High Court in WP No.30999 of 2002 have been implemented and decision was communicated to all the Petitioners.


