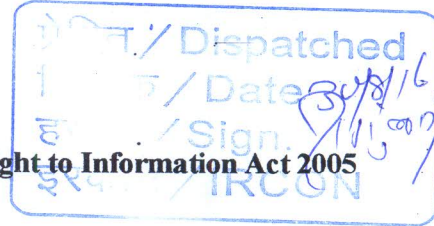

III. Discussions:

1. Applicant is informed that pay fixation is HR matter and is not related to Company Secretary. Initially, the company was very small, hence, the establishment work was being looked after by Company Secretary. Now the entire HR matters is managed HRM section of Ircon.
2. As regards to pay fixation, the applicant has raised 28 applications/ 1st Appeals under RTI Act which have been disposed of. Besides, he has raised this issues through various representations directly addressed to the Company and through the Ministry of Railways which have been disposed of.
3. Applicant is advised that he should not waste the time of the Public Authority by raising the similar issues again and again. Similar issues raised again will not be entertained by the Public Authority. Hence applicant should desist in seeking the similar information.
4. Applicant is also informed that RTI is not a forum of grievance redressal. Under RTI, the applicant can only seek the information. Public authority will not attend to any grievance under RTI or give any opinion, advice, suggestions or reply to his questions raised why, what, where, etc.

IV. Right of Appeal

If applicant is not satisfied with the information provided by CPIO, he can file an appeal to the 1st Appellate Authority within 30 days of the issue of this letter in terms of Section 19 of the Right to Information Act, 2005. Particulars of 1st Appellate Authority are as under:
