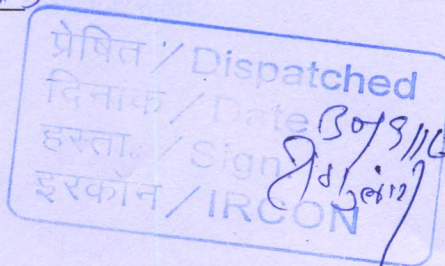


IV. **Decision:** Application is disposed of.

13.08.97. The following comments are offered on the
representation of Shri Mahmood Kasim Sahib,, Photographer:-

1. Shri Mahmood Kasim was mobilised to Iraq in the year
1984. As per the terms and conditions which he accepted and
signed, his salary was fixed at ID 25+ U.S.\$ 253. At this
distant date a review of the same is not possible because he had
accepted the above terms and conditions prior to his
mobilisation.
2. He is undergoing the penalty of withholding of
increment upto 15.5.98. Hence he is not eligible for promotion.
3. The penalty was imposed after conducting an Enquiry
and as per orders of the Disciplinary Authority.
4. His allegation of discrimination on the basis of his
religion ~~and~~ are without foundation and are denied.
