**II. Ground of Appeal:**

Applicant has made an appeal on the grounds that he may be supplied a copy of Ircon's letter dated 24.02.2015. In the subsequent paragraphs he has raised various grievances and sought replies to his queries.

**III. Discussion:**

1. CPIO while disposing his application on 22.08.2016 informed that letter dated 24.02.2015 was supplied by CPIO along with his letter dated 02.12.2015. Applicant is informed that if he desires another copy of Ircon letter dated 24.02.2015, he should contact CPIO/Ircon and collect the copy after payment of additional fees amounting to Rs.82/-.

2. Applicant has filed 79 RTI application / appeal till date. He has been repeatedly informed that RTI is not a forum of grievance redressal. Further under RTI public authority is not supposed to give the answers of the queries.

**IV. Appeal:**

If applicant is not satisfied with the decision of the First Appellate Authority, he can file an Appeal to the 2<sup>nd</sup> Appellate Authority within 90 days of the issue of this letter in terms of Section 19(3) of the Right to Information Act, 2005.
