Appeal is disposed of.

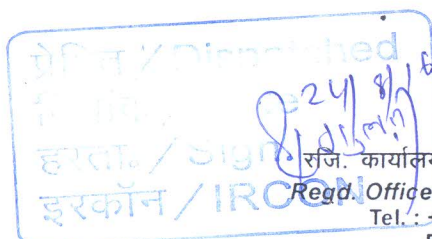
