Applicant has made an appeal against the CPIO's letter No. IRCON/PIO/CO/RTI/05/698/531 dated 13.07.2016, in which applicant has sought zerox copies of note which was put up to Competent Authority for disposal of his application dated 22.08.2015. Applicant has been supplied the information by CPIO accordingly.

2. Applicant has not mentioned the grounds of appeal. Rather he has raised fresh issues in his appeal regarding fixation of pay during his posting in Iraq project.
