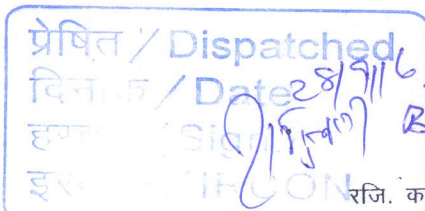
**B. Grounds of Appeal:**

Applicant has made an appeal on the grounds that:

- She has not received the reply of her RTI application from CPIO
- CPIO is obliged to provide the reply on RTI to applicant in a safest way and it is privilege of the applicant to know on it.
- Provide the letters in registered or ordinary, if ordinary no hope and trace out will not be possible, hence it is the responsibility of CPIO.

**C. Discussions:**

Applicant gave a mail to CPIO on 19.09.2016 seeking the details of dispatch. CPIO advised that reply has been sent to the applicant vide letter No. IRCON/PIO/CO/RTI/05/738/604 dated 14.09.2016 and also attached the copy of said letter along with proof of dispatch. Applicant vide mail dated 20.09.2016 addressed to CPIO confirmed the receipt of mail along with attachment and conveyed "Sir thank you for reply and attachment". Applicant is advised that under RTI, information is provided by ordinary post only. CPIO has provided the information within 28 days of the receipt of the application. Since, applicant has confirmed the receipt of information hence; there is no substance in the appeal of the applicant.




**D. Appeal**
