2. In his RTI application dated 16.08.2016, applicant has given reference of CPIO's Order No. IRCON/PIO/CO/RTI/05/551 dated 24.03.2015. CPIO's Order dated 24.03.2015 is in reference to the issues related to Disciplinary Action. In the present RTI application, applicant has raised the grievance regarding pay fixation. There is no relation between the reference and the content of the application.

3. Applicant should note that RTI is not a forum of grievance redressal. Under RTI only the information available with the Public Authority is supplied.

4. This is 67th application of the applicant under RTI.
