Now, this office is in receipt of a reply from the concerned department, and as per that the information sought by you cannot be provided because it is wide and vague. The view taken by the concerned department in the matter is reproduced as under:

"Applicant expects that Public Authority should compile the above information from the various files of the project and then supply the same. As per the RTI act the information as available with Public Authority can only be supplied. Public Authority is not required to compile and collate the information and then supply the fresh created information to the applicant. Hence the information being wide and vague cannot be provided."

Accordingly, your application dated 22.07.2016 under R.T.I. Act, stands disposed of.


